

Arkansas Absentee Ballot Application

You may mail, fax, or hand-deliver this application to your County Clerk. You may also have a Designated Bearer, Administrator, or Authorized Agent hand-deliver your application to your County Clerk. You may choose anyone to act as your **Designated Bearer**. An **Administrator or Authorized Agent** must complete an Affidavit of Authorized Agent and return it with this application. Applications that are mailed or faxed must be received seven (7) days before the election. Applications that are delivered in person by you or your designated bearer must be received by the close of business on the day BEFORE the election. Applications that are delivered by an Authorized Agent must be received by 1:30pm on Election Day. I REQUEST AN ABSENTEE BALLOT BECAUSE (CHECK ONE):

- I will be unavoidably absent from the polling site on Election Day.
- I am unable to attend the polls on Election Day because of illness or physical disability.
- I am unable to attend the polls on Election Day because of residence in a long-term care or residential facility licensed by the state.

I RESIDE (CHECK ONE):

- Within the county in which I am registered to vote
- Outside the county in which I am registered to vote
- Outside the territorial limits of the United States

I AM REQUESTING AN ABSENTEE BALLOT FOR THE FOLLOWING ELECTION:

I WILL RECEIVE MY ABSENTEE BALLOT (CHECK ONE):

- In person. I will come to the office of the county clerk by the time the office regularly closes on the day before the election.

By Designated Bearer, Administrator, or Authorized Agent:
A Designated Bearer can only pick up two absentee ballots and can only do so within fifteen days of a preferential primary or within seven days of a general primary election. Administrators or Authorized Agents must complete an Affidavit of Authorized Agent and return it with this application.
